Please return entries by March 31st March 2018 with a **large stamped addressed envelope (please ensure you attach the correct postage)** to the appropriate steward overleaf.

Please read and observe the following set of Rules. They are not only for your safety, but will also help the organisers in the running of the Rally your help and co-operation will be greatly appreciated.

I declare that during the whole period of the rally my entry will be covered by Public Liability Insurance, which includes rally use, and where necessary by a Boiler Explosion policies having a limit of indemnity of not less than £2,000,000 (Two Million Pounds).

I further declare that in case of any event taking place wholly or partly on the Public Highway, that the vehicles hereby entered are covered by insurance as required by the Road Traffic Act 1960, which is valid for such part of this event which will take place on such roads defined in that Act.

I further declare that the Boiler of any steam engine carries a current Board of Trade Inspection Certificate and that I will produce documentary evidence of such insurance for your inspection before participating in the rally.

I confirm that the driver/drivers of any vehicles owned by me holds and is not disqualified from holding a Licence to drive a vehicle of the appropriate class.

NO ENTRY WILL BE ACCEPTED AFTER THE CLOSING DATE.

Observe all site safety rules as set out in the public safety policy. Copies exhibited at pay gates

Please ensure that you follow stewards and section leaders' requests.

There will be no parking for exhibitors to park with your exhibits.

All safety ropes in working areas must be maintained at all times.

The speed limit on the site is 5mph great care must be taken when large vehicles are manoeuvring.

No person may drive an exhibit on site unless they have a current driving license and the vehicle is insured for public liability.

Please put all litter in the receptacles provided.

Elson tips are provided so please use them.

Do not park your private vehicles or caravans to obscure the exhibits

Always be near your exhibit or be available if needed in case of problems.

If you see something you think is not right or is unsafe and dangerous, report it to the Safety Officer or section leader, immediately

When arriving on site report to your section, if you have to park your vehicles wait to be sited and don't block entrances or exits. Please be patient.

At night if you are camping on site think of others regarding loud music or noise of any kind, particularly after 11.00pm

No generator use after 10.00 p.m. and before 7.00a.m please.
